#### **POST DIRECTOR CHANGES**



#### Delaware: Sean E. Moriarty, Ed.D.

The Delaware Department of Safety and Homeland Security (DSHS) announced Sean E. Moriarty, Ed. D. as Executive Director of the new Police Officer Standards and Training Commission (POST).

POST, now a new division within DSHS, was created through House Bill 206 and signed into law in August to replace the Delaware Council on Police Training (COPT). Legislators, advocates, community members and law enforcement worked together to create the new Commission.

With more than 30 years of law enforcement experience, he will lead the Commission in establishing hiring and training standards for Delaware police officers as well as overseeing significant allegations of police officer misconduct. In addition, he will advise the Delaware Police Accreditation Commission (DPAC), which is responsible for establishing policy and standards for police agencies, assisting agencies with

standardization and accreditation, and issuing guidelines for local police oversight commissions or boards.

"Director Moriarty's commitment to upholding the highest standards of law enforcement makes him best suited to lead this new commission at this time. His wealth of experience and leadership will undoubtedly make a positive impact in his new role. I look forward to his continued contributions to our law enforcement community," said Safety and Homeland Security Secretary Nathaniel McQueen Jr.

Director Moriarty, who recently retired from the State Police as a Major, focused significant time and effort on education, policy development, community engagement, and police professionalization during his career. He held various positions during his career including Director of Training for the DSP Training Academy and Administrator for COPT. In this capacity, he oversaw all aspects of recruitment, in-service, firearms, canine, and elective training. This included revising the entire training curriculum and enhancing instructor development.

"The Delaware Police Officer Standards and Training and the Police Accreditation Commissions will play a significant role in collaborating and assisting law enforcement agencies towards greater professionalization, standardization, and accountability. I am extremely grateful for the opportunity to continue serving our citizens in this new role," said Executive Director Moriarty.

He holds a Doctorate of Education in Innovation and Leadership, a Master of Science in Criminal Justice, a Bachelor of Arts in Criminal Justice, and he is a graduate of the Federal Bureau of Investigation National Academy.

### Vermont JTL and Curriculum Development

IADLEST will be conducting a full Job Task Analysis (JTL) related to police academy training in Vermont. It is expected that this will lead to a reworking of the academy curriculum.

### Job Task Analysis for the Vermont Police Academy

Jon Blum, Project Manager

IADLEST is conducting a job task analysis (JTA) study for the Vermont Police Academy (VPA). To recap, a JTA is the systematic process of identifying specific performance tasks that define a job. JTA studies are essential for providing training academies needed data to develop evidence-based and legally defensible curricula that prepares newly minted officers to perform successfully.

Because Vermont's law enforcement officer population is smaller than most states (<1500 total), IADLEST has been asked to survey *every* sworn officer working in Vermont. The survey will be distributed in January 2024 using a proprietary online platform. Officers assigned to work uniform patrol duties will be asked how frequently they performed a specific task within the last twelve (12) months using a sliding numerical scale similar to the one below.

Never = 0 Once = 1 2-3 times = 2 Once per month = 3 Once per week = 4 Several times per week = 5 Daily = 6 More than once per day = 7

First-line supervisors, management, and command staff will be asked to rate the consequences of inadequate performance (i.e., criticality) by uniform patrol officers for a specific task using a sliding numerical scale similar to the one below.

Minimal = 1 Not very serious = 2 Serious = 3 Very serious = 4 Disastrous = 5

First-line supervisors, management, and command staff will also be asked when officers should be taught a specific skill (e.g., basic training, field training, in-service training, advanced in-service training).

The results of the Vermont JTA study will serve as the foundation for revising the VPA's basic academy curricula for all law enforcement officers. IADLEST recently submitted a RFP seeking to be the vendor that develops Vermont's new basic academy curriculum.



### Reducing Commercial Motor Vehicle Crashes Be Part of Solution!

#### FREE 2-hour and 4-hour Nationally Certified Training Courses

Texas consistently leads the nation in large truck fatalities and has one of the highest rates of bus fatalities each year. Even with the designated officers whose focus is on commercial motor vehicle traffic enforcement, there are simply not enough of them to reduce the number of crashes. A successful strategy being adopted throughout Texas is to train and encourage non-CMV certified officers, to include local and county law enforcement members, to actively engage large trucks and buses operators for common violations, e.g. speeding, disregard of a traffic signal, etc., thereby reducing crashes and fatalities.

The Truck & Bus Traffic Enforcement Training Program is presented at **no cost** to the participant or agency and re-emphasizes the need for all **sworn officers** to engage large trucks and buses safely and effectively to reduce the rate of crash injuries and fatalities. - Identify the common traffic violations associated with truck and bus crashes.
- Understand the safety considerations that apply before, during and after a stop.
- Detect potential indicators of serious vehicle defects and/or criminal activity.
- Recognize the documentation required when conducting a truck or bus traffic stop.





The Academy Innovations research project is supported by the U.S. Department of Justice COPS Office. The project is designed to develop evidence-based training methods for the law enforcement industry. The goal is to identify improved methodologies for delivering entry-level law enforcement training content.

### **Project Results**

This one-of-a-kind research project utilized ongoing academy classes to answer the following questions:

1. Does frequency of instruction on a topic (integrated into the curriculum at specific intervals) impact knowledge retention?

2. What impact does online instruction have on knowledge retention (positively or negatively) compared to traditional classroom delivery?

The results have been published in two formats:

A practitioner's guide now available on the COPS Office website

And

A technical paper published in The Policing Journal.






Constitutional Policing Curriculum Support to Academies



As IADLEST's reputation for expertise and its ability to deliver grows, we receive more and more requests for our presence among the major players in law enforcement nationally.

As an example, here are some of the committees, agencies and events that our Deputy Director, Brian Grisham has attended recently:

VIRTUAL ACADEMY.





The National Decertification Index has been under development in various forms for over 20 years.

It has provided law enforcement agencies with a tool to help screen the backgrounds of prospective new hires, be they new recruits or officers transferring from another agency.

Records regarding officer misconduct are entered by police officer standards and training agencies (POST Agencies), or other certifying authorities. These records are made available for query by police, sheriffs, and other qualified agencies in order to give those agencies full information about individuals applying for hire.

Over the life of the system a total of over 52,566 records have been entered by 49 certifying agencies.

#### **UPDATE:**

The RFP has been published and an online demonstration of the NDI was held for vendors to acquaint them with the current system and to answer questions about the expansion project.

We expect to award the contract in April 2024.

#### **Expansion Project**

With the sponsorship of the US Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, the NDI is about to embark on a radical redesign and expansion of services.

Some states have made query of the NDI a legal or regulatory requirement for the hiring agencies under their jurisdiction.

We are anticipating adding more federal agencies to the system.

# National Law Enforcement Academy Resource Network (NLEARN)

NLEARN is a service of IADLEST offered at no cost to law enforcement instructors, academy personnel, training coordinators, and patrol officers.

#### IADLEST and VirTra Award Atoka Police Department with a Free Simulator as Part of Taskforce Santa Project

December 14, 2023, The International Association of Directors in Law Enforcement Standards and Training (IADLEST) and VirTra (Nasdaq: VTSI) have announced the selection for the Taskforce Santa project, which provides a public safety training simulator to a deserving agency free of charge. On December 13, Atoka Police Department in Tennessee received its V-100® training simulator after being selected from over one hundred applicants nationwide.




