Instructions

This form is used to document the criteria of each applicant for IADLEST's International Certified Instructor Program (ICI). Applicants must satisfactorily complete each section of this application and upload the required documents and reference contact information.

Current IADLEST Nationally Certified Instructors (NCI) have the option to complete the application form and additional foreign country, language and/or interpreter experience information, or to complete entire ICI application process if they wish to update their instructor information. SECTION I: Applicant Information

Type or print legibly, the applicant's last name, first name, middle initial, last four digits of Social Security number or identification number, and date of birth. Enter the applicant's employer name and telephone number. If retired or no longer employed, list a contact individual from your last employing agency who can verify your employment status and/or instructor experience.

SECTION II: Applicant Instructor Certification

This section must be completed for all applicants. Enter the date the applicant completed a law enforcement academy, POST, federal, or national law enforcement Instructor Development Course or its equivalent. Please remit a copy of the successful completion certificate or proof of course attendance. Submit any other instructor certificates, letters of awards, or certificates of merit for your presentation of instruction or curricula development.

SECTION III: Applicant Resumé, Instructor Biography and Professional Photo

Please submit your current resumé indicating your instructional/curriculum design experience. Also, include an instructional biography, not to exceed 500 words, and a professional photo. These items will be displayed on the IIC website after certification is granted.

NOTE: If applicable, include countries where you have presented law enforcement instruction. Include languages that you are fluent in speaking and or understanding, or experience in using interpretation equipment or interpreter services. These items will be displayed on the ICI website after certification is granted.

SECTION IV: POST DIRECTOR, LEO TRAINING ACADEMY DIRECTOR OR IADLEST MEMBER ENDORSEMENT

All applicants can be recommended for the ICI by their law enforcement academy director, State POST Director, a law enforcement officer Academy Director from a federal or national academy, or IADLEST Member in Good standing. All applicants must have at least three (3) years of experience as a police instructor at the agency, state, federal or national level, recognized law enforcement association, or at a college or university.

SECTION V: THREE REFERENCE CONTACTS

If Section IV cannot be completed, the applicant must provide three (3) references to be contacted to verify the applicants' instructional and curriculum design experience, and good moral character.
