#### Law Enforcement Experience

I've participated in the (USSC) Utah Safe School Commission. It was commissioned by Governor Herbert in (2018) in coordination with the Utah State Legislature with the intent to make recommendations for prevention of school violence and school shooter response. I was then invited to and am currently participating in the School Safety Advisory Committee now called the School Safety Collaborative, hosted by the Utah State Board of Education.

**Exchange Club of Sandy:** In 2016 I served as the President of the Sandy Exchange Club which is a service organization that focuses on recognition of American pride, community service, child abuse prevention and recognition of outstanding juvenile citizens in Sandy City.

**Sandy Day of Pride Chairman:** In 2017-2018 I served as the Chairman for Sandy Pride, which is a clean up, trail maintenance and beautification event held in Sandy City. I was responsible for the coordination of fund raising, bag delivery and volunteer efforts.

**EVO (Emergency Vehicle Operations) instructor:** As a department instructor I completed the Utah Department of Public Safety EVO instructor course. I helped train new officers and performed annual trainings for all other Sandy officers for their annual qualifications.

Training included; emergency response and pursuit driving. Each discipline is multifaceted requiring individual skill qualifications and a pursuit course. Also policy review, radio operations.

**Department ATV (All Terrain Vehicle) Instructor:** With patrols in the Dimple Dell Park and foothills, department personnel needed training on the safe operations of these vehicles (four wheelers initially, then side by side many years later). I am a National ATV Safety Institute certified instructor. As such I can competently train our officers to safely operate ATV's for patrol purposes.

**Citizens Academy Instructor:** I've assisted other instructors on numerous occasions with these courses. I took the role of safety officer, EVO instructor, role play coordinator and "day in the life" coordinator.

**FBI certified instructor development:** Teaching and instructing requires more than just a good personality. Lesson plans must be developed with specific learning goals and teaching methods employed. In the law enforcement world we must also consider policy and liability

reduction. I completed this 40 hour course and implemented what I learned as I developed training for the department and personal pursuits.
